- (b) To accuse Nicaragua of having disrupted military equilibrium in Central America (NOTE: GOH instructions review bill of particulars in this regard in extensive detail);
- (c) To accuse Nicaragua directly of sponsoring arms traffic, terrorism, and subversive movements in the region as well as attempting to maintain state of tension in Central America;

- 4. Subsequent to reftelecon Ambassador spoke again with Minister Flores who was aware of latest UN developments.

 Flores said that GOH instructions to Permrep were to



continue insistence on regional approach and to insist on Contadora report to CAS prior to considering whether or not Perez de Cuellar should form part of Contadora Group. Honduras does not reject possible SYG involvement at some future time but insists on report to CAS from Contadora Four before proceeding further along that track. Flores also said that Honduran Permrep will attend Kidkpatrick breakfast May ten. He also suggested that consideration be given to inviting Guatemalan Permrep if possible.
