thank you for your letter of January 5, 2005 informing me that nor records have been found concerning Karl Meier (case #249F-05), Otto Puschmann (case #250F-05), José Rakos (case #251F-05), Maria Ham(m)mernyk (case #252F-05), Ernst Josef Bach (case #253F-05), Hans Jochen Dominik (case #254F-05), Franz Josef Labens (case #255F-05), Franz Josef Lederer (case #265F-05), Wilhelm Benno Schulz (case #267F-05), Vladimir Velikotny (case #258F-05), Johannes Weiss (case #259F-05) and Ernst Georg Wallenstein (case #260F-05).

At least in the cases #249F-05 (Karl Meier) and #250F-05 (OttoPuschmann) I am quite sure that there are Army Intelligence records, since I found

- a) a CIC Austria report dated 14. August 1947 concerning Puschmann, Otto @Meier, Karl mentioned in CIC file XE 11758 (Kauder-Klatt, Richard), p. 9, and
- b) a note of the British Security Service dated 25 February 1953 referring to information from CIC Austria on Otto Puschmann @Karl Meier and Walter Moebius, b. 20.03.1912, 1953 residing at Vienna IV, Belvederegasse 8

Before filing an appeal I would like to ask you to check again whether there are Army Intelligence reports concerning OttoPuschmann.

Furthermore, I also request under the provisions of the Freedom of Information Act the release of records relating to the following individuals:

- 1) Grunweghe, Robert @Groenes, Josef, b. 15.09.1894 St. Petersburg/Russia, 1947 residing Vienna III, Kerbergasse 13
- 2) Moebius, Walter, b. 20.03.1912
- 3) Wallenstein, Ernst Ludwig, b. 05.03.1906 Frankfurt/Main
- 4) Weiss, Dominik, b. 06.03.1899 Vienna
- 5) Wiesinger, Josef, b. 10.03.1913 Kapfenberg/Austria
- 6) Wrabel, Robert, b. 18.12.1900 Vienna, d. 02.10.1967 Salzburg

The request is in connection with research on the history of the German Military Intelligence Service during World War II. Since my research is of a scientific character and the results of it will be published in a book and thus will contribute to public knowledge, I herewith request for waiving all fees.
