I am writing this letter in behalf of my adopted brother, please let me tell you a little bit about him, DANIEL MARTIN KELLEY was a solder in the United States Army his rank was E4 the Unit he was with is Company D, 5Th Btln., 7 Th Cavalry, 1ST Cavalry. His home city is Dorchester Ma., Date of loss: 25 April 1968. (Country of Loss: South Vietnam:) Loss Coordinates, are as follow 162133 N 1070641E STATUS (In 1973 Killed/Body NOT RECOVERED)Category: 2 Aircraft/ Vehicle Ground

Senator .SP4 Daniel M . Kelley did not ask to go to Vietnam He was Ordered without any questions .SP 4 Daniel Kelly went to Vietnam, SP4 Kelley & PFC Guillory were on a search and clear mission. In the vicinity of Thua Thien Province, Souh Vietnam. They were riflemen in Company D, 5 TH Battalion, 7<sup>TH</sup> Cavalry Division. This unit was ambushed by enemy force. SP4 Kelley was shot in the neck and died. SP4 Scott was shot in the chest and PFC Guillory was shot and then hand grenades were thrown within 3-4 feet of him the three were observed for a minimum of two hours, and no signs of life were detected. Because of heavy fire, the unit broke into small groups in order to escape and invade, and had to leave their casualties behind. A search was attempted three times, but could not be completed because of hostile actions.

Senator please take notice: In 1985, a private citizen obtained a lengthy document describing in great detail a prison camp near Hue, South Vietnam, and identified a number of Americans he had seen held there by their photographs. Some of them he positively identified, and another list he considered "possible". A number of Americans he identified had already been released from Vietnam in 1973. Daniel M. Kelley was one of the names on the "possible" list I would like to know what our Government is doing to recover SP4 Kelleys remains and to bring him HOME for a descent Burial . Pleas tell us, the American People that they are not for gotten because we fly a POW/MIA Flag on our flag poles. Guillory, Kelley and Scott are listed with honor among the missing because no remains were recovered. Despite the possible identification of the Vietnamese source of Kelley's photo, their cases seem quite clear. For others who are listed missing, resolution is not as simple. Thousands of reports such as the one received in 1985 have surfaced since the end of war, convincing many authorities that hundreds of Americans were left behind Alive.( There can be no "Peace With Honor" as long as our men and women are held in enemy hands).

Mr. President please just think from 1968 up until now is a long time to be forgotten. Also what is Congress doing about this matter? I can assure you Senator Kennedy, I will not stop looking for my adopted brother SP4 DANIEL MARTIN KELLEY. Or others who are still over there in Vietnam.
