Suspicious profits sit uncollected Airline investors seem to be lying low

THE WAR

Investors have yet to collect more than \$2.5 million in profits they made trading options in the stock of United Airlines before the Sept. 11 terrorist attacks, according to a source familiar with the trades and market data.

The uncollected money raises suspicions that the investors – whose identities and nationalities have not been made public – had advance knowledge of the strikes.

"Usually, if someone has a windfall like that, you take the money and run," said the source, who spoke on condition of anonymity. "Whoever did this thought the exchange would not be closed for four days.

"This smells real bad."

The source and others in the financial industry speculate that the purchaser or purchasers — having initially assumed the money could be picked up without detection — now fear exposure, or that the account has been frozen.

Mark Morford:

The markets were closed for four days after the attack, giving investigators time to notice the anomalous trades.

Securities regulators and law-enforcement agents, throughout the United States and Europe are investigating unusual patterns in short sales and the purchase of "put" options, both of which are financial-market bets that the price of a given stock will fall. Authorities here and abroad have not publicly disclosed any conclusions they have reached and refuse to discuss the case.

There was an unusually large jump in purchases of put options on the stocks of UAL Corp. and AMR



I believe that our organization deserves the status of "news media" based both on our journalistic background and the purpose for the requested documents.

The Center for Public Integrity is a non-profit organization dedicated to investigative journalism. Almost our entire staff, with the exception of administrative positions, is made up of journalists, reporters and researchers. The Center publishes a newsletter and online publication called the *Public i*. Though the Center's printed newsletter has a limited circulation, the Center's web publications have received as many as 50,000 "web hits" following the release of its stories. Over the years, hundreds of media organizations have covered articles broken by the Center. Our original reporting has unearthed national stories including the Lincoln Bedroom, the Harkin stock trading scandal and potential conflicts of interest dealing with Halliburton.

Since the Center's inception, our organization has regularly received awards reserved for the media from organizations like the Society of Professional Journalists and Investigative Reporters and Editors. Though our organization is a small non-profit, we are a legitimate part of the media, just like other nonprofits including National Public Radio and the Associated Press.

The Center for Public Integrity intends to use the requested documents as a source to write news stories and other publications in its capacity as a news provider. Currently the Center is compiling information on various presidential candidates in hopes of publishing news stories that will inform the public about each politician's political record. As investigative journalists, will plan extract and analyze the substantive content of these records and provide context by comparing them with other documents already collected.
