Dear Mr. Thompson:

I was both shocked and dismayed at your untimely response to my appeal for information regarding the administration of easements by both Lisa Klinger and Cynthia Lane. It has come to my attention that internal documents exist that demonstrate that in fact both Lane and Klinger are actively seeking to utilize the rouse of enforcement of scenic easements to violate individuals private and civil rights.

Their pattern of behavior is becoming critical to the presentation of an action against both the United States Department of Agriculture and anyone else who may be involved in this conspiratorial action to deny and deprive people of their civil rights and property rights guaranteed under the United States Constitution.

I am astonished that after nearly two years, you would simply deny the freedom of information act appeal, and attempt to hide both Klinger and Lane behind the privacy act. I have never sought, nor am I now seeking any information relating to any medical conditions of either Klinger or Lane, but I am seeking all internal memoranda generated by Klinger and Lane regarding their administration of scenic easements, their relation to individuals whom they are attempting to manipulate these easements for their own benefit and/or the benefit of the United States Department of Agriculture, and what I consider to be unlawful activities.

I assure you I will pursue all documents related to Klinger and Lane, as well as internal documents generated by them in their capacity as an employee of the United States Department of Agriculture which relate to their administration of scenic easements in an unlawful fashion, and in a manner designed to deprive people of their civil rights.
