My office represents the State of Montana in a number of civil lawsuits filed against it by individual plaintiffs concerning the W.R. Grace, Libby, Montana mine site. Pursuant to the Freedom of Information Act, 5 U.S.C. § 552, et seq., and its implementing regulations, this letter serves as a request for copies of all documents relating to the W.R. Grace & Co. vermiculite mine and processing, storage, shipping, and other facilities (the facilities) located in and around Libby, Montana, specifically including:

- 1. Any and all documents identifying individuals who worked at the site;
- 2. Any and all studies or other documents addressing the health of individuals that worked at the site:
- 3. Any and all studies or other documents addressing the health of individuals that exposed to vermiculite or asbestos removed from the site:
- 4. Any and all studies addressing asbestos, tremolite or vermiculite concentrations in the ore, rock, water, air, or any other media at or near the site;
- Any and all inspection reports of or studies by or documents of the United States Environmental Protection Agency, United States Bureau of Mines, United States National Institute of Occupational Safety and Health, United States Public Health Service, and any other federal agency that conducted inspections or made trips to or near to the site, including, but not limited to:
 - a. National Institute for Occupational Safety and Health;
- 6. Any and all inspection reports of the site by the State of Montana Department of Labor, State of Montana Department of Mines, or any other state agency; and
- 7. Any and all studies by any private individuals or groups, including W.R. Grace & Co., of environmental or health conditions at the site, including, but not limited to:
