We represent the defendant, New England Medical Center Hospitals, Inc. (NEMCH), in the above-referenced litigation. As you are aware, other defendants in this action have requested, pursuant to the Freedom of Information Act (FOIA), access to United States government documents regarding the human growth hormone project. Please accept this letter as a formal request made by NEMCH for access to these documents under FOIA.

In addition, it is our understanding that a substantial delay has occurred in locating the documents and in responding to the FOIA requests made by other parties to this litigation. The plaintiff in this litigation has alleged that the decedent, Stacey Crair, received growth hormone under the government's program that was allegedly contaminated with the virus or protein causing Creutzfeld Jacob Disease. The plaintiff has alleged that the defendants in this litigation were involved in the extraction, administration. or distribution of the growth hormone. The defendants cannot properly prepare their defenses to the plaintiff's claims or meaningfully participate in discovery without first obtaining and reviewing the documents in the government's possession. We would be willing to enter into a Stipulated
