## Dear Sir:

In March of 2003, I reported a nuclear safety problem at FitzPatrick Nuclear Power Plant to the site Resident Inspector, Leonard Cline. I subsequently filed a "whistleblower" complaint in April of 2003 with both the Department of Labor and the NRC seeking protection under Section 211 of the Energy Reorganization Act. I was terminated by my employer, Entergy, in November of 2003 as a result, or so I believe, of my reporting of this nuclear safety issue.


Special Investigator Mark Mullen of the Office of Investigations (NRC) investigated my claim of discrimination and recently completed his investigation and forwarded his report for signatures. Yesterday, I received an "interim" determination letter from Dave Vito (Region I Senior Allegation Coordinator). The letter stated that contents of the Office of Investigations Case No. 1-2003-034 could be accessed by myself by filing a FOIA request with the NRC. This letter is intended to accomplish that objective.

Specifically, I am requesting a copy of the transcript derived from Special Investigator Mark Mullen's on-site interviews with FitzPatrick / Entergy / NRC personnel. These taped interviews were conducted at the plant between November 3 - 7, 2003. In conversation with Mr. Mullen, I was informed that this transcript could be made available to me in a FOIA request, but that names of the individuals interviewed would most likely be deleted. I am aware of this and do not mind if their names are deleted.

Time is of the essence in this matter. I recently had an ALJ hearing on my discrimination complaint (April 27-28, 2004). The ALJ has held the hearing "open" for 30 days to allow for the preparation of the hearing's transcript. New evidence in the case will be allowed within this thirty day "window".

To expedite matters, I hereby agree to pay any and all fees / charges associated with this FOIA request.
