MEMORANDUM FOR THE RECORD:

SUBJECT: Board, Of Directors Overt/Covert Guidance 1 May 92

The Board accepted Col briefing on the proposed concept of an overt NRO, as presented, with the following comments. This memorandum should be considered the **Overt NRO** Baseline upon which implementing planning actions are based.

Unclassified NRO mission:

The mission of the National Reconnaissance Office (NRO) is to ensure that the US has the technology and overhead assets needed to acquire superior worldwide intelligence in war and peace. To this end, the NRO conducts research and development and acquires and operates overhead systems for the collection of intelligence.

Unclassified Identity of the DNRO

The Director of the NRO is Mr. Martin C. Faga. Mr. Faga's DNRO duties are in addition to his duties as ASAF (Space) and Director, DSPO.

Unclassified Deputy Director and Deputy for Military Support

The Deputy Director of the NRO is Mr. Jimmie D. Hill!

The Deputy for Military Support is ADM Daniel March. ADM March is also the Deputy Director of the Defense Support Project Office.

Unclassified key NRO officials

Mr. is the Director of IMINT Programs for the NRO.

The size of the NRP remains compartmented.

Previously Approved:

- Propose changes to National Space Policy to allow some discussion of satellite reconnaissance at unclassified level
- -- Include NRO as single organization in USG responsible for satellite intelligence collection
- Decompartment the "fact of" certain systems and limited system facts for military support for release at Secret level
- Preserve the following features of the NRO
 - -- Concept of streamlined management process
- -- Ability to conceal appropriate technology, organization and operations consistent with sources and methods protection
- -- Continuation of "must know" authority for the DNRO within
- -- Ability to support military operations from planning through execution

- Mr. Faga not limited by Fuhrman Panel recommendations is implementing those he has agreement on and looking at others
- Need to address contractor relationship after NRO is overt Mr. Hill thinks it could stay the same covert
- Need clear ground rules about what is classified
