SUMMARY

ACTION REQUIRED: Mr. Faga--Sign Mr. Hill--Coord ADM March--Coord

PROBLEM: A revised draft memo to the SECDEF and the DCI is provided in response to your direction.

BACKGROUND: See previous memo.

DISCUSSION:

- We have responded to your guidance to officially release the names of only the top three managers. We have dropped the organization chart itself because it was devoid of any content in addition to the names and titles of these managers.
- You asked that the sentence expanding on the intelligence mission of the NRO be deleted in the mission statement. We are instead proposing to include a more limited statement based on past or contemplated official disclosures. (Arms control and indications and warning have already been officially disclosed with respect to photo-reconnaissance in national space policy and open testimony; military support will in effect be disclosed when

SUMMARY

ADM March's title is disclosed.) We also think that acknowledging the military support mission will support your goal of improving support to operational military customers.

- At your request, we have added a discussion of the impact on management practices of the NRO. This turned out to be more difficult than we had anticipated. We have discussed this subject with the General Counsel and have reflected his views.
