- -- THESE SANCTIONS APPLY TO KUNTSEVICH ONLY, AND NOT TO RUSSIA OR THE GOVERNMENT OF RUSSIA.
- -- WE HAVE NO INFORMATION THAT THE RUSSIAN GOVERNMENT WAS INVOLVED IN OR SUPPORTED THIS ASSISTANCE.
