AFTER CONVEYING "GOOD NEWS" ON ANOTHER SUBJECT (REF B) TO PRESIDENT CHIANG I THEN REFERRED TO THE RECENT VISIT OF THE U.S. NUCLEAR TEAM AND SAID THAT AS A RESULT OF A REVIEW OF THE TEAM'S FINDINGS AND FURTHER DISCUSSIONS IN WASHINGTON, I HAD BEEN REQUESTED TO DELIVER TO THE PRESIDENT A LETTER FROM THE SECRETARY OF STATE ON THIS SUBJECT AND TO SUPPLEMENT THIS WITH SOME ADDITIONAL TALK-ING POINTS. (PRESENT WITH THE PRESIDENT AT THIS MEETING WERE VICE MINISTER OF FOREIGN AFFAIRS CHIEN AND PRESIDENT'S AIDE, JAMES SOONG.)

AS SOON AS THE PRESIDENT WAS AWARE OF THE SUBJECT I WISHED TO DISCUSS, HE SAID THAT HE HAD DESIGNATED THE MINISTRY OF FOREIGN AFFAIRS TO DEAL WITH THIS MATTER AND ASKED THAT I APPROACH THEM. HE WENT ON TO SAY THAT THE UNITED STATES GOVERNMENT MUST REALIZE THAT ON NUMEROUS - OCCASIONS HE, THE PRESIDENT, HAS FORMALLY DECLARED (INCLUD-SECRET

ING IN TESTIMONY IN THE LEGISLATIVE YUAN) THE POLICY OF THE REPUBLIC OF CHINA, I.E., THAT THE REPUBLIC OF CHINA HAS NO INTENTION OF MANUFACTURING NUCLEAR WEAPONS, AND THIS POLICY REMAINS UNCHANGED.

- 3. RECOGNIZING THAT THIS WHOLE MATTER INVOLVED MANY HIGHLY TECHNICAL QUESTIONS THE PRESIDENT SAID HIS GOVERNMENT HAS BEEN READY TO TOLERATE MANY INVESTIGATIONS BY THE UNITED STATES. THE GROC HAS ACTUALLY ALREADY DONE EVERYTHING IN THIS FIELD IN ACCORDANCE WITH U.S. GOVERNMENT REQUESTS AND OFFERED FULL COOPERATION. ON A NUMBER OF OCCASIONS, U.S. SCIENTISTS HAVE WORKED SIDE BY SIDE WITH THOSE FROM THE REPUBLIC OF CHINA AND WORK HERE HAS GONE ON OFTEN UNDER U.S. DIRECT SUPERVISION. NO OTHER COUNTRY HAS OFFERED TO WORK IN SUCH A COOPERATIVE SPIRIT. THERE IS NOTHING THAT IS NOT OPEN TO U.S. SURVEILLANCE.
- 4. THE PRESIDENT ADDED THAT WHAT THE UNITED STATES IS DOING IN THIS FIELD VIS-A-VIS THE ROC IS DEALING A SERIOUS PSYCHOLOGICAL BLOW TO THE SCIENTIFIC AND TECHNICAL EXPERTS OF THIS COUNTRY. HE SAID THAT NEVERTHELESS THE GOVERNMENT HAS MADE EFFORTS TO AVOID A PUBLIC DISCUSSION ON THIS SUBJECT OF THE U.S. ATTITUDE AND ACTIONS AND DOES NOT WANT TO HAVE THE PUBLIC INCITED BY THEIR LEARNING OF THE ACTIONS AND DEMANDS BY THE UNITED STATES.
- 5. THE PRESIDENT, REFERRING TO MANY CLEAR AND UNEQUIVOCAL STATEMENTS ALREADY MADE, SAID THAT THE UNITED STATES MUST TAKE THE PRESIDENT'S WORD. IN ANY CASE, IF THERE ARE QUESTIONS THAT REQUIRE FURTHER DISCUSSION OR SOME NEED FOR INFORMATION REMAINS UNSATISFIED, THE MATURE OF THIS SHOULD BE MADE QUITE CLEAR. MOREOVER SOMEONE COULD BE SENT FROM THE U.S. TO WATCH OVER THE ROC PROGRAMS DAY BY SECRET

NEVERTHELESS HE SAID HE WOULD TAKE THIS ONE MURE OPPORTUNITY TO REAFFIRM HIS BASIC POSITION WHICH IS THAT THE REPUBLIC OF CHINA WILL NOT MANUFACTURE NUCLEAR WEAPONS. HE THEN ASKED ME TO PURSUE THIS MATTER WITH THE MINISTRY OF FOREIGN AFFAIRS IF I WISHED TO GO FURTHER INTO THE MATTER.

I ACKNOWLEDGED WHAT THE PRESIDENT HAD SAID. MADE REFERENCE TO THE NEW LAW UNDER WHICH THE PRESIDENT OF THE UNITED STATES MUST OPERATE AND NOTED THAT HE IS REQUIRED BY LAW TO SATISFY HIMSELF ON A NUMBER OF POINTS IF CERTAIN MATERIALS AND EQUIPMENT ARE TO BE EXPORTED BY I REFERRED ALSO THE UNITED STATES TO A FOREIGN COUNTRY. TO THE VARIOUS AGREEMENTS BETWEEN OUR TWO GOVERNMENTS, PARTICULARLY THOSE REACHED IN THE SPRING OF 1977. I THEN ONCE MORE REFERRED TO THE LETTER FROM SECRETARY VANCE AND THE TALKING POINTS AND ASKED THE PRESIDENT WHETHER HE AGREED TO RECEIVE THESE; HE ASSENTED AND I HANDED DYER BOTH DOCUMENTS WITHOUT HAVING PREVIOUSLY READ THEM ALOUD.

COMMENT: PRESIDENT CHIANG, ONCE HE KNEW THAT I WISHED TO DISCUSS THE NUCLEAR QUESTION, WAS MORE OBVIOUSLY ANNOYED AND DISTURBED THAN I HAVE EVER SEEN HIM IN THE COURSE OF OUR DISCUSSIONS ON THIS OR ANY OTHER ISSUE. PART NO DOUBT HE RESENTS THE FACT THAT THE UNITED STATES GOVERNMENT, IN SPITE OF HIS REPEATED PERSONAL REASSURANCES THAT THE REPUBLIC OF CHINA WILL NOT MANU-FACTURE NUCLEAR WEAPONS, NEVERTHELESS KEEPS QUESTIONING HIS GOVERNMENT'S, AND THEREFORE HIS, GOOD FAITH AND INTEN-TIONS ON THIS SCORE, LITHER DIRECTLY OR INDIRECTLY. HIS ... DISTRESS MAY ALSO RELATE TO HIS FEELING THAT SOME OF HIS SCIENTISTS (PERHAPS GENERAL TANG ABOVE ALL) HAVE PUT HIM ONCE AGAIN INTO THIS EMBARRASSING POSITION. BELIEVES TOO THAT THE U.S. BECAUSE OF ITS UNIQUE RELATION-SHIP WITH THE REPUBLIC. OFCHINA AND THE LATTER'S EXTREME

THIS GOVERNMENT IN A FASHION WHICH FEW OTHER COUNTRIES WOULD TOLERATE.

8. IT NOW APPEARS THAT GOVERNMENT-TO-GOVERNMENT BUSINESS ON NUCLEAR MATTERS WILL HAVE TO BE CONDUCTED LARGELY WITH THE FOREIGN OFFICE. THIS IS WHAT APPARENTLY WAS MEANT TO BE CONVEYED BY THE FOREIGN MINISTER'S ORAL MESSAGE TO ME ON AUGUST 26 (TAIPEI 5736). I ANTICIPATE THAT THE NEXT STEP IN THE DIALOGUE THAT I INITIATED TODAY WILL BE AN INTERVIEW WITH THE FOREIGN MINISTER (OR POSSIBLY WITH VICE MINISTER CHIEN). THERE IS NO QUESTION OF COURSE THAT THE PRESIDENT WILL READ OVER WITH GREAT CARE THE LETTER FROM SECRETARY VANCE AND THE TALKING POINTS. THEREAFTER, WE WILL PROBABLY RECEIVE BOTH SOME ORAL RESPONSE FROM THE FOREIGN MINISTER AND PROBABLY A WRITTEN ACKNOWLEDGEMENT OF THE SECRETARY'S LETTER, MEANWHILE AND AFTERWARD WE WILL. HAVE TO CONTINUE AS IN THE PAST TO MAKE OUR JUDGMENTS ON THE BASIS ALSO OF THE OTHER INFORMATION WE ARE ABLE TO GATHER.
