ON MARCH 16, 1976, RAYMOND MOLINA, A U. S. CITIZEN, WHO TOOK PART IN THE BAY OF PIGS INVASION IN CUBA, PROVIDED THE FOLLOWING INFORMATION IN BUENOS AIRES, ARGENTINA:

MOLINA HAD PREVIOUSLY PROVIDED INFORMATION REGARDING AN INTERVIEW WITH ARGENTINE ARMY GENERAL CARLOS ALBERTO DALLA TEA, THE SECRETARY GENERAL OF THE ARGENTINE ARMY ESTADO MAYOR (HIGH COMMAND), WHICH TOOK PLACE ON MARCH 14, 1976, IN BUENOS AIRES AT THE HOME OF THE SON OF JORGE ANTONIO.
