- 2. SUMMARY: ERNESTO SAMPER, THE CURRENT FRONT-RUNNER IN THE 1994 PRESIDENTIAL CAMPAIGN, HAS BEGUN TO ASSEMBLE HIS CAMPAIGN STAFF. THE GROUP, FOR THE MOST PART, REPRESENTS SERIOUS, CAPABLE, AND HONEST LIBERAL PARTY STALWARTS. OUR LIST OF SAMPER SUPPORTERS HAS SEVERAL UNSAVORY CHARACTERS AND ONE NARCO, BUT SAMPER HAS NOT INVITED THESE TO ACTUALLY JOIN HIS STAFF. END SUMMARY.
- 3. SO FAR ERNESTO SAMPER, THE LIBERAL PARTY MAGNATE MAKING A SECOND BID FOR THE PRESIDENCY, IS THE MOST LIKELY OF ALL THE CANDIDATES TO BE COLOMBIA'S NEXT PRESIDENT. A CAREFUL ASSESSMENT OF WHAT WE MIGHT EXPECT FROM A SAMPER ADMINISTRATION SHOULD INCLUDE A REVIEW OF THE MOST PROMINENT CAMPAIGN ADVISORS, PEOPLE WHO ARE MOST LIKELY TO OCCUPY KEY POSITIONS IN A SAMPER ADMINISTRATION.

5. SERPA MANAGED SAMPER'S FIRST RUN AT THE PRESIDENCY IN 1989-90. A PROFESSIONAL POLITICIAN SINCE 1974, SERPA REPLACED ASSASSINATED (BY NARCOS) PROCURADOR CARLOS MAURO HOYOS IN 1988, THEN BECAME PRESIDENT BARCO'S GOVERNMENT MINISTER IN MARCH 1990. SERPA IS A LEFT-OF-CENTER JURIST WHO AVOIDED COMMENT ABOUT EXTRADITION AND NARCOTICS TRAFFICKING UNTIL JOINING BARCO'S ADMINISTRATION, AT WHICH POINT HE TOOK A TOUGH STAND AGAINST THE DRUG CARTELS.
