ON APRIL 29, 1983, EUR/SOV DIRECTOR SIMONS CALLED IN MINISTER-COUNSELOR SOKOLOV OF THE SOVIET EMBASSY TO RESPOND TO THE SOVIET PROTEST OF APRIL 6, 1983 (REF: MOSCOW 04152) AND PASSED OVER US NOTE REJECTING IT. SOKOLOV ACCEPTED THE RESPONSE WITHOUT COMMENT. THE TEXT OF THE NOTE REJECTING THE SOVIET PROTEST IS AS FOLLOWS:

THE DEPARTMENT OF STATE NOTES THAT THE UNITED STATES FULLY RESPECTS THE REQUIREMENTS OF INTERNATIONAL LAW AND THE SAFETY OF AIRCRAFT OPERATIONS, AND AFFIRMS THAT ITS POLICY IS TO AVOID INTRUSIONS INTO SOVIET AIRSPACE. 2. THE USSR ON APRIL 6, 1983, OFFICIALLY PROTESTED THAT US CARRIER PLANES (OPERATING OFF THE KURIL ISLAND CHAIN) HAD INTRUDED INTO SOVIET AIRSPACE OVER THE HABOMAI ISLANDS LOCATED NORTH OF HOKKAIDO, JAPAN. THIS REGION, OCCUPIED BY THE USSR SINCE THE CLOSE OF WORLD WAR II BUT CLAIMED BY JAPAN, HAS BEEN A SOURCE OF US CONCERN SINCE 1952, WHEN A US PLANE WAS SHOT DOWN BY THE SOVIETS AFTER A CLAIMED INTRUSION OF SOVIET AIRSPACE.

- 3. ON APRIL 12, 1983, TWO SOVIET AIRCRAFT INTRUDED INTO US AIRSPACE OVER NUNIVAK ISLAND, ALASKA. AS THIS WAS THE FIRST OVERFLIGHT OF US AIRSPACE BY A SOVIET BOMBER SINCE MARCH 1969, THE INTRUSION CAN BE SEEN AS A DIRECT RESPONSE TO US MILITARY ACTIVITIES IN A REGION OF INCREASING GEOSTRATEGIC IMPORTANCE TO THE USSR.
- 4. THE US HAS LONG RECOGNIZED THE JAPANESE CLAIM TO THE ISLANDS OF HABOMAI, SHIKOTAN, ETOROFU, AND KUNASHIRI (THE JAPANESE "NORTHERN TERRITORIES"). WITH REGARD TO SOUTHERN SAKHALIN AND THE NORTHERN KURIL ISLANDS, THE US STATES THAT THE QUESTION OF SOVEREIGNTY REMAINS TO BE RESOLVED. THIS POSITION SERVED AS THE BASIS OF THE US DEPARTMENT OF STATE REJECTION OF THE APRIL 1983 PROTEST.
- 5. THE SOVIET PROTEST WAS PREDICTABLE FOR A NUMBER OF GEOSTRATEGIC REASONS. FOREMOST IS THAT THE NORTHERN TERRITORIES HAVE BEEN THE CENTER OF A SIGNIFICANT SOVIET MILITARY BUILDUP OVER THE PAST DECADE. THEN, TOO, THE USSR ZEALOUSLY GUARDS WHAT IT BELIEVES ARE ITS PREROGATIVES IN THE SEA OF OKHOTSK. THROUGH BOTH DEEDS AND WORDS THE SOVIETS HAVE NOTIFIED THE WEST THAT THEY SECRET

THE TWO "HINGES" AND THE STRAITS THAT PERMIT PASSAGE THROUGH THE KURIL ISLAND CHAIN MUST BE KEPT OPEN IF THE WEST IS TO ENSURE THAT THE SEA OF OKHOTSK DOES NOT BECOME A SOVIET "LAKE" THROUGH DEFAULT. TO THAT END, US NAVAL VESSELS MAKE OCCASIONAL ENTRIES INTO THE SEA OF OKHOTSK.—THE MOST RECENT BEING IN FEBRUARY 1983. 
