2. (S) [REDACTED] STATUS OF SYSTEMS: USTRANSCOM SYSTEMS, INCLUDING THE UNCLASSIFIED LOCAL AREA NETWORK AND GLOBAL TRANSPORTATION NETWORK (GTN) REMAIN FULLY OPERATIONAL. CONTINUAL ANALYSIS OF TRAFFIC AND CONNECTION ATTEMPTS TO USTRANSCOM AND GTN FIREWALLS AT SCOTT AFB IL AND ROBBINS AFB GA REVEAL NO UNAUTHORIZED ACTIVITY.

3. (S) [REDACTED] OPERATIONAL IMPACT: NONE

4. (S) [REDACTED] ISSUES: REQUEST JOINT STAFF J39 AND J6K COORDINATE WITH DISA, THE SERVICE CERTS, AND INVESTIGATORY AGENCIES ON TIMELY RELEASE OF DATA CONCERNING TECHNICAL SPECIFICS OF INTRUDER TECHNIQUES AND METHODOLOGY. INFORMATION PROVIDED IN PREVIOUS MESSAGE TRAFFIC HAS BEEN EXTREMELY HELPFUL IN DEVELOPING AN ADDITIONAL LINE OF DEFENSE. HOWEVER, ADDITIONAL DETAILS WILL PROVIDE JSTRANSCOM ANALYSTS AND SYSTEM ADMINISTRATORS WITH A RECOGNIZABLE INTRUDER PROFILE TO AID IN STRENGTHENING THE COMMAND'S DEFENSIVE COUNTERINFORMATION CAPABILITY.
