(b)(6),(b)(7)(C) [redacted] (b)(6),(b)(7)(C) [redacted] was made aware that an individual based on my machine, (b)(6),(b)(7)(C) [redacted] had illegally accessed military machines on the Internet. The person who contacted me at home was (b)(6),(b)(7)(C) [redacted] at Myriad Corporation, the ISP that leases our connectivity to the Internet. I immediately drove to Myriad and was told that the law enforcement officer was going to need to talk to me. On arrival I was taken to (b)(6),(b)(7)(C) [redacted] office where he was currently talking to (b)(6),(b)(7)(C) [redacted] an investigator from the Air Force. (b)(6),(b)(7)(C) [redacted]

(b)(6),(b)(7) [redacted] I was told that I would be receiving an official letter in the mail and a copy would be faxed to (b)(6),(b)(7)(C) [redacted]. The field agent would not take any information from me at the time and did not want any passwords or information. The field agent instructed me (if I was willing to cooperate and only then) to turn off the trimming of my log files in my crontab and not to change any configurations of the machine aside from that. Upon my request, the field agent gave me some general times that hacking activity was noted as occurring. Assisted by (b)(6),(b)(7)(C) [redacted] I issued the following commands to shut off trimming. (b)(6),(b)(7)(C) [redacted] This killed crond and ensured that trimming would no longer occur. I then went home and logged in from home. (b)(6),(b)(7)(C) [redacted] and I had a significant amount of data that was not backed up on our system. We immediately went and bought a zip drive, drove to her office, and downloaded backup copies of our all of our client webpages, home directories, and email. We left the system files, etc on the machine. (b)(6),(b)(7)(C) [redacted]

(b)(6),(b)(7)(C) [redacted] Once I arrived at home, I started looking around to see if I could piece together exactly who the culprit was. My first step was to check our /var/log/message file that logs system messages. I found no activity that I deemed as unusual during the alleged hacking times. Next, I did a 'last' command to see who was logged in during those times. One user had been logged in at the approximate times of the hacking indicated by Field Investigator (b)(6),(b)(7)(C) [redacted]. Below is a list of the last logs that we captured with the user we suspected. This account is shared between (b)(6),(b)(7)(C) [redacted] and the overseas user. (b)(6),(b)(7)(C) [redacted] indicates that she was logged in on Feb 5, 16:25-16:33 and that it was indeed her at that time only. (b)(6),(b)(7)(C) [redacted]

I have highlighted a time range that seemed to match with what (b)(6),(b)(7)(C) indicated. However, I now see that I jumped the gun a bit in that the date was wrong. (b)(6),(b)(7)(C) indicated a break in on Feb 5 00:40:02 EST and one Feb 4 10:00 EST. According to this last log, I suppose that the bat account could not be suspect. The wtmp file was set to trim because I was more concerned with disk space than security so more data is not available. In my haste I accidentally lost the 'last' that contained all the users and their log in times. It will be available on the tape restored system once the court order is obtained. (b)(6),(b)(7)(C)

About this time, I was contacted by another field investigator. (b)(6),(b)(7)(C)

office where the machine resides. He also made arrangements to get backup copies of my drives. It was totally under my consent and he made it perfectly clear to me that I didn't have to backup the hard drives or cooperate with them at all. (b)(6),(b)(7)(C) also gave me some file names that the hacker had placed on previous systems to aid me in looking for information. The files he named were as follows: (b)(6),(b)(7)(C)

After he called, I started poking around on my system some more. I edited no files, nor did I create any files in system areas. All that I have included were taken from telnet session logs. I examined the ftp logs and the message logs. I found nothing that I felt was important. Then I started looking for files on the system that had been recently updated. I found some suspicious files namely a file named (b)(6),(b)(7)(C) in one of the /var directories. The contents of the file were binary. However, I was able to make out that the file contained a list of all the files in my root directory tree. (b)(6),(b)(7)(C)

After this I went to sleep. I awoke the following morning and started working on getting information from my server. This was 2/9/98 around 08:00. I logged in and checked /var/log/messages and found many ICMP errors for many different IP numbers. (b)(6),(b)(7)(C) logged in on her (b)(6),(b)(7)(C) account and did a lookup on the IP numbers. Many were af.mil sites. We immediately paged (b)(6),(b)(7)(C) and left a message for (b)(6),(b)(7)(C)
