1. (U) USCINCPAC SITREP 02 IS A CONSOLIDATED USPACOM RESPONSE.
2. ~~(S/REL UK/GAN)~~ CURRENT SITUATION: WE HAVE DETECTED NO NEW COMPUTER INTRUSIONS IN USPACOM OVER THE PAST 24 HOURS. UPDATE TO DISA-PAC INTRUSIONS MENTIONED IN USCINCPAC SITREP #1: DISA-PAC HAS COMPLETED A TOTAL REBUILD OF ONE OF THEIR AFFECTED DNS SERVERS. TWO OTHER DNS SERVERS REMAIN DOWN. DISA-PAC HAS ESTABLISHED EFFECTIVE WORK-AROUNDS TO MINIMIZE OPERATIONAL IMPACT.

F. ~~(S/REL UK/CAN)~~ RECOMMEND DISA ORCHESTRATE A NATIONAL RESPONSE TO THE INTRUSION ACTIVITY. PERCEPTION IS THAT USAF, THROUGH AFINC, HAS THE LEAD. AFINC RECOMMENDATIONS ARE UNFORTUNATELY ONLY GOING TO USAF ADDRESSEES, MAKING IT DIFFICULT FOR US TO ORCHESTRATE A THEATER-WIDE RESPONSE.
