G: Yeh, say I just wanted to say that the people in the community have identified your colleague over at Defense as a real roadblock and I don't know what--they are liable to do a lot of screaming about him very soon

K: Well, that is true , he was a roadblock.

G: You say was ?

K: No, I've thrwn the fear of God in him.

G: I don't see why they--I mean whatever they want to do, they do, it's up to them.

K: That's right.

G: I think what they are planning to do, they are going to go after George Bush and various other people. Tower, Connally, what have you.

K: That's their problem, but one thing I resent beyond description that they're coming after me.

G: I thought they were not.

K: There isn't a day that goes by without my receiving a threatening phone call from Jackson.

G: Well they can't control him.

K: About the mismanagement of crisis, how's he going to prove that this was a strategic disaster.

G: But he is--has his own testifying and they do not control him. He dominates them more. But there has been no comment ffrom the community --as a matter of fact they called me to say you had received some wires and so forth that would be matters of which they have no control.

K: Because we have done everything that is humanly possible.

G: I think there is a _____ of real weakness on our part at this point and particularly the President, I mean in the total Watergate setting --failure to act in a decisive effective way in supplying what they need.

K: Well you can be sure that I am aware of that--that we run into massive sabotage which has now been broken.

G: That's important. And I'm talking about this really from the standpoint of the kind of problems that Fred Buzhardt and myself have run into and it's a matter in which he and I share

K: We have now have--this Administration is a disaster. I had a strategy which would have wound up with a ceasefire by Monday or Tuesday --if the Defense Dept Arabists would have allowed me to do it. Now they sabotaged it, now they have to pour in high-profile stuff into Israel, now we are going to wind up with the Arabs mad
