IN BUENOS AIRES, ARELLANO WILL DISCUSS WITH THE ARGENTINE MILITARY ANY INFORMATION THEY HAVE REGARDING THE ACTIVITIES OF GENERAL (RETIRED) CARLOS PRATS, FORMER COMMANDER-IN-CHIEF OF THE CHILEAN ARMY. ARELLANO WILL ALSO ATTEMPT TO GAIN AN AGREEMENT WHEREBY THE ARGENTINES MAINTAIN SCRUTINY OVER PRATS AND REGULARLY INFORM THE CHILEANS OF HIS ACTIVITIES. IN ASUNCION, ARELLANO WILL MAKE 4 COURTESY CALL ON PRESIDENT ALFREDO STRAUSSNER IN THE NAME OF THE JUNTA. HOWEVER, HIS REAL MISSION WILL BE TO TALK WITH GENERAL (RETIRED) ROBERTO VIAUX, WHO IS IN EXILE THERE. ARELLANO WILL INFORM VIAUX THAT THE JUNTA HAS DECIDED THAT FOR INTERNAL POLITICAL REASONS, IT MUST STAND BY THE DECISION OF THE CHILEAN SUPREME COURT WHICH BANISHED VIAUX FROM CHILE FOR A FIVE-YEAR EXILE SENTENCE. ARELLANO WILL ALSO ASCERTAIN WHETHER VIAUX HAS ANY FINANCIAL PROBLEMS AND WILL ACT IN THE NAME OF THE JUNTA TO ARRANGE FOR
