OFFICER'S STATEMENT:

On the above date and time, I was temporarily assigned to the Vice Section for a special detail. I was specifically assigned to investigate the chronic prostitution related activity in the Central Division area of San Diego. There have been numerous complaints of prostitution related activity in this section of the city. Prostitutes and their customers frequent the area in an attempt to solicit acts of prostitution. I was directed to wear casual attire and to stand on the sidewalk in the 3494 block of Main Street. Detective [redacted] was running the detail and Officer [redacted] was working with me.

While I was standing at this location, I saw Awlaki driving/walking EB bound on 3494 Main. Awlaki stopped at 1900 Thor. I spoke to Awlaki. To the best of my recollection, the following conversation took place:
