 Meakins few days ago McClellan of AFL/CIO under impression still  
 possible for Meakins' lawyer to seek court restraining order.  
 Dept requests Congen get clarification this point and inform us.  
 In any case BG TUC and American trade unionists concerned with  
 matter intend maximize propaganda advantages should Meakins be  
 deported.

Dept concurs approach Congen has made to Governor expressing  
 concern regime's policy trying to bar foreign labor leaders  
 unfriendly to PPP.

Our information on McCabe is that he entered BG about week  
 ago, left for Port-of-Spain, then reentered and plans return  
 Washington early next week. END
