1. THE FOLLOWING STATEMENT WAS RELEASED AT THE MAY 18 NOON PRESS BRIEFING:

"THE UNITED STATES STRONGLY DEPLORES THE CONVICTION AND SENTENCING BY A SOVIET COURT OF DR. YURIY ORLOW, THE LEADER OF THE MISCOW PUBLIC GROUP TO PROMOTE DESERVANCE OF THE HELSINAL FINAL ACT IN THE USSR. THE HARSH SENTENCE WAS AGGRAVATED BY PROCEDURES AND ACTIONS DESIGNED TO YET THE CON-HUMILIATE BOTH THE DEFENDANT AND MRS. ORLOV. DUCT FOR WHICH OR. ORLOW IS BEING PUNISHED WAS THE MONITOR-ING OF THE PERFORMANCE OF THEIR GOVERNMENT UNDER THE CSCE SUCH PARTICIPATION BY PRIVATE CITIZENS IN THE FINAL ACT. CSCE PROCESS SHOULD BE WELCOMED BY SIGNATORY GOVERNMENTS RATHER THAN REPRESSED BY THEM.
