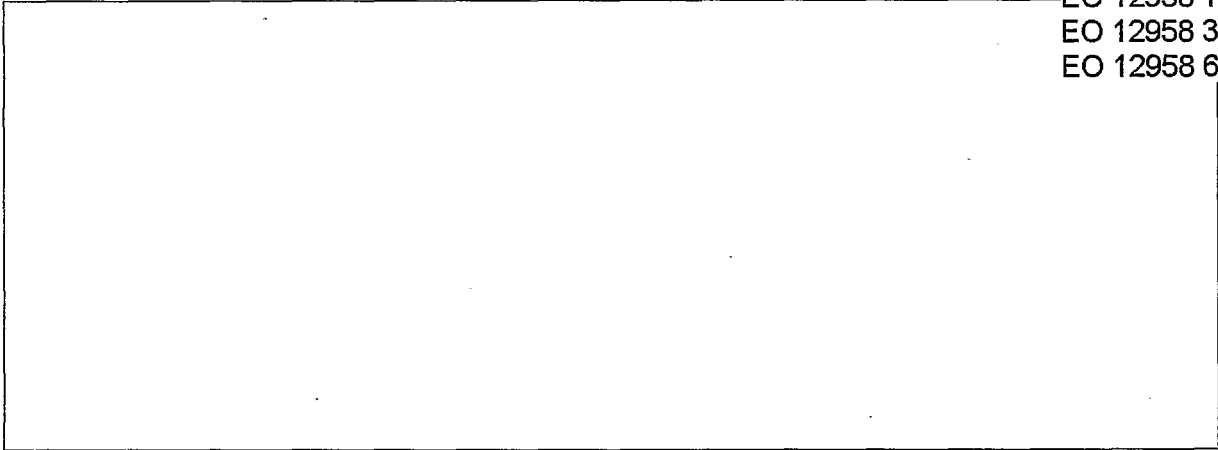

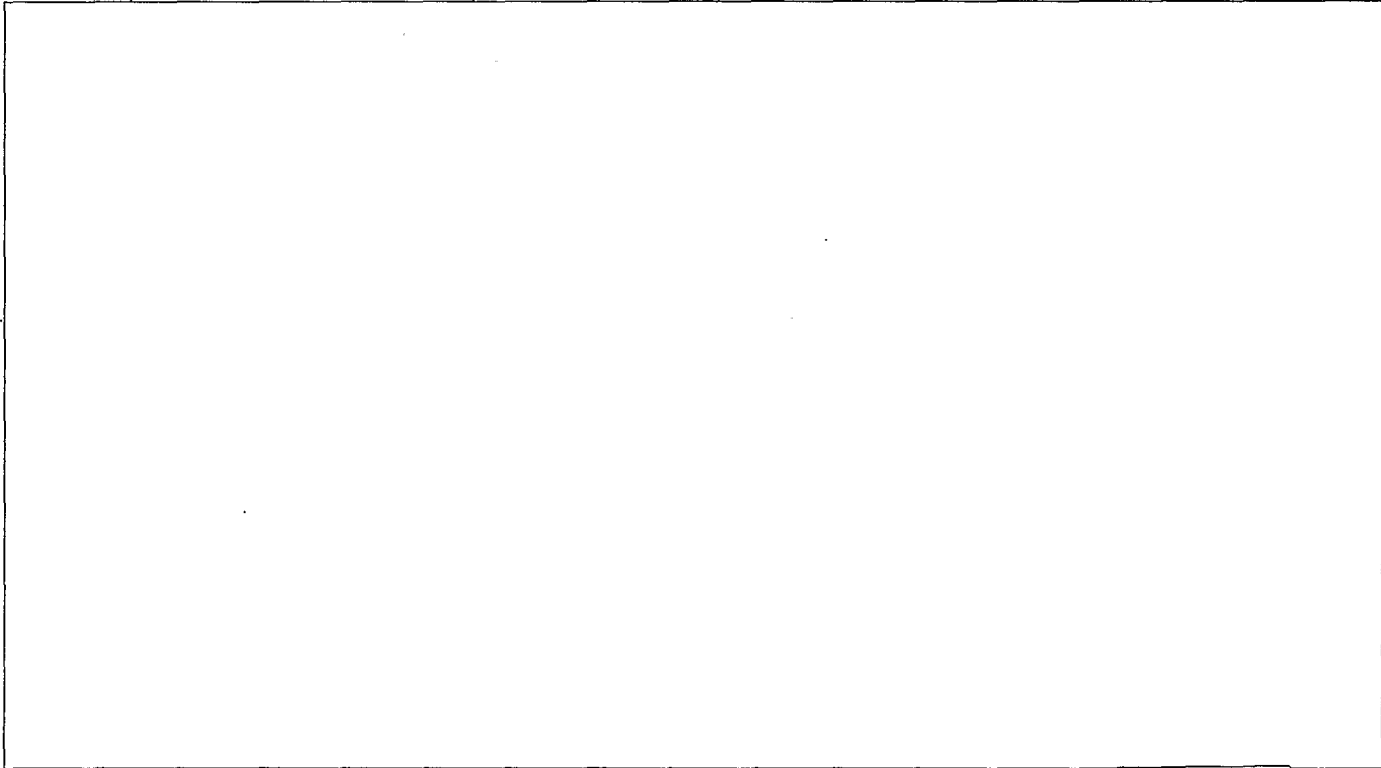

[REDACTED] EVENTUALLY AN AGREEMENT WAS REACHED TO COLLABORATE POLITICALLY AND MILITARILY. THE PRIMARY GOAL OF THIS COLLABORATION WAS TO CONFRONT ISRAEL AND THE UNITED STATES, WHILE THE SECONDARY GOAL WAS TO UNDERMINE ARAB REGIMES WHICH SUPPORTED ISRAEL AND THE UNITED STATES.
