2. THROUGH DAD, I WAS INVITED TO LUNCH BY BRIG GENERAL RAMON JUAN ALBERTO CAMPS COMMANDER OF THE REMOUNT AND VETERINARY SERVICE, ON WEDNESDAY 130LY 25) AT HIS NEARBY HOOTRS. 1 HAD MEYER MET GENERAL CAMPS, BUT HIS REPUTATION OF BEING ONE OF SENERAL SUAREZ MASON'S EXECUTIONERS WAD PRECEDED WITH HE WAD HIS TROOPS LINED UP IN FRONT OF HIS BUILDING FOR HE TO REVIEW WHICH I DID WITH THE TRADITIONAL "BUENDS DIAS. TROPA DE LA REMONTA" AND THEY REPLIED IN UNISON "BUENGS DIAS SENOR EMBAJADOR, " LT COL. DES REIS, ASST. ARMY ATTACKE, ACCOMPANIED ME TO THE LUNCH. WE WERE ESCORTED TO CAMP'S OFFICE, WHERE HE STOCO IN HILLIARY FASHION -- CARBED IN WHAT COULD BE DESCRIBED AS A TANG-OFF ON A GENERAL PATTON ENSEMBLE. THE "REMONTA" WAS NO RELATIONSHIP TO ANY TANK UNIT BUT IT IS THE LAST VESTIGE OF MIAT WAS ONCE ABOUN AS CAUALRY, JUDGING FROM PHOTOS OF HIMSELF ON MIS DESK, IT CAN BE SAID CAMPS HAS SEEN HUCH BETTER DAYS, IT IS APPARENT HE HAS LOST A GREAT BEAL OF WEIGHT, IS TERSE AND HAS A PIERGING LOOK.

3. CAMPS' EXCUSE FOR WARTING TO MEET HE WAS THE SHARING OF A COMMON INTEREST-HORSES. HE BROUGHT OUT SEVERAL CHARIS OF RIS HORSE OPERATIONS LINE, IN AND CROSS BREEDING. HE TOOK GREAT PRIOE IN TELLING HE ME WAS THE LARGEST HORSE BREEDER IN THE COUNTRY. WE THEN UNDERTOOK ANOTHER MEY PRIORITY-CUNCK, HE WAS SERVED A SPECIAL PLATE-FOR HEALTH REASONS. HE WOULDN'T TOUCH THE WINE-WHICH FOR AN ARGENTINE IS SACRILEGIOUS, BUT HE BID PARTAME IN MIS SMARE OF PILLS. HE DIDN'T WASTE ANY TIME IN GETTING TO THE SUBJECT OF SUBVERSION, TEPRORISM ETC.

4. SUBVERSION BY IDEOLOGY: CAMPS GOT GREAT RELIEF IN TELLING MS NOW ME MOURD LECTURE TO PARENTS OF RECRUITS FROM TIME TO THE. CAMPS' EXPLANATION TO THE PARENTS AND SONS WAS THAT THE OUTY OF THESE RECRUITS WAS NOT TO DIE FOR THE SALVATION OF THEIR COUNTRY BUT TO KILL FOR THEIR COUNTRY, HE EMPHASIZED STRONGET TO RECRUITS THAT THEIR DEJECTIVE WAS TO LEARN TO MILL. AS HE MADE THESE STATEMENTS, HE WOULD TENSE UP AND RECORE IMPERVIOUS TO THE WORLD AROUND RIM. HE GESTURED-WITH MIS MANDS WHILE HIS PIERCING EYES GAVE THE SEMBLANCE OF HIS TRYING TO LINE UP THE CROSS-HAIRS IN A TELESCOPIC REFLE SIGHT ON WIS TARGET, WE THEN WENT INTO A DISSERVATION OF HOW PARENTS, MENS MEDIA AND DISSIDENTS WERE CORRUPTING THE MINDS OF TOUNG. IMPRESSIONALSE PEOPLE. HE WENT INTO WEIGO HETAPHONS AND SAID MON NO ONE SHOULD EVER QUESTION THE WIRTURE OF HIS COUNTRY. ME THEN DESCRIBED HOW MILITARY FORCES HAD DEFEATED TERECRISES ON THE BATTLEFIED, BUT NOW THERE WAS A NEW WAR ON TROSE OF FOREIGN IDEDLOGY, SUCH AS MARKISH AND THE DIFFERENT SHADES OF COMMUNISH, CAMPS MADE THE ARALDOY OF THESE PROPLE WITH FOREIGN IDEOLOGIES BEING THE SAME AS MAVENG A ROTTEN APPLE IN THE BARREL -- THE ROTTEN APPLE HAD TO BE ELIMINATED. HE ALSO USED THE ANALOGY OF A STRONG TRUNK ON A TREE VITH SECK LINGS EGG.

THE THREAT OF NEWS MEDIA ETC., I THOUGHT IT WAS TIME TO DIS-CUSS JACOED SIMERMAN, I TOLD CAMPS THE GOOD LORD HAD GIVEN HES COUNTRY HANY PLUCSES BUT YET THE MINUSTS WERE EATING THE PLUSSES. I TOLD HIM ARGENTINA'S PHAGE ABROAD WAS A BLACK AND NEGATIVE ONE -- A COUNTRY CATEGORIZED AS ONE OF THE WORST BUMAN RIGHTS VIOLATORS DI EARTH. BUT THIS TIME, CAMPS WAS TENSING UP LIKE A FIGHTING ROOTTER READY FOR MATTLE, BUT L MAD THE FLOOR AND WACH'T ABOUT TO RELINOUISH IT. I EXPLAINED ARGENTINA'S IMAGE COULD IMPROVE SUBSTANTIALLY BY THE RELEASE OF TIMERMAN, HE BEAT HE TO THE DRAW, AS HE BELLOWED "TIMERMAN WILL NEVER BE RELEASED. " CAMPS PROCEEDED TO BERATE TIMERMAN AND USED EVERY ADJECTIVE AND EXPLETIVE TO PAINT HIM AS AN IMMORAL, AMORAL AND SUBVERSIVE TYPE. I ASKED CAMPS THAT IF FINERMAN WAS SUCH A SCOUNDREL THE DID THE MILLIARY TRIBUNAL AND THE SUPREME EDURY ABSOLVE WITH DE ALL MEDIG BOING. HE BED NOT HEET THE SCHOOL THE TOTION THE THEO THERMAN WAS A DANGEROUS SUBVERSIVE AS HE HAD POISONED THE MINDS OF YOUNG PEOPLE BY HIS MARKISTS WRITINGS IN LA OPINION, HE THEN CONTINUED THAT SO LOWS AS THOUSANDS OF PEOPLE BIED DUE TO TIMERMAN'S ENCOURAGEMENTS BY HIS TEACHINGS TO FIGHT AN ESTABLISHED GOVERNMENT, TIMERMAN CAN'T AND SHOULD NEVER BE RELEASED

5. TIMERHAM THE "CAUSE CELEGRE:" I THEM TOLD CAMPS IT WAS RETOND MY COMPRESSION OF NOW AND INTELLIGENT AND SOPHISTICATED COUNTRY LIKE ARGENTINA COULD ASSUME AN IMPORTANT ROLE IN THE CHAIT LILE MOUTO MHEN REA COALUMENL OLLICITY 2 MEME LOWEARE TELLING HE HO CHARGES EXISTED AGAINST TIMERMAN BECAUSE COA COULDN'T FROVE ANYTHING AGAINST WIN. CAMPS WOULD REBUT BY STATING PROOF EXISTED TIMERHAM HAD INFLUENCED ARGENTINES BY HIS SURVERSIVE WRITINGS. I THEN SUGGESTED TO CAMPS-WITH TORROLE IN CHEEK--HE WAS A PATRIOTIC PERSON. I EXPLAIMED IT WAS HIS DUTY TO CONSIDER THE WELFARE OF THE WHOLE MATION AND NOT ONLY HILITARY COLLEAGUES. I YOLD HIM IN MY EXPERIENCE IN TRAVELLING THROUGHOUT THE WATTON OF ARCENTING THE CEMERAL POPULACE CARED LESS THAN ONE LOTA ABOUT TIMERMAN'S FATE. 1 TOLD HIM I FOUND ARGENTINES INDIFFERENT TO TIMERMAN, THEREFORE. HOW COULD IT BE POSSIBLE THAT ONE SCOUNDREL -- AS HE CALLED TIMERNAH--COULD BE PERHITTED TO GIVE HIS COUNTRY SUCH A MORRIBLE IMAGE ABROAD. I TOLD HIM ONE PERSON WAS NOT WORTH SATRIFICING THE WELFARE OF 26 MILLION ARGENTINES, I TOLD HIM

THAT SO LONG AS TIMERMAN WASIN CUSTODY EVERY DAY WOULD PROVE TO BE AN IRRITANT FOR HIS COUNTRY ON A GLOBAL BASIS. I STATED EVEN IF TIMERMAN - IF RELEASED - WOULD WRITE ADVERSELY ON ARGENTINA HIS EXPOSURES WOULD PROBABLY BE OF A NON-RECURRING NATURE. ON THE OTHER HAND, SO LONG AS HE IS IN CUSTODY HIS STORY IS BEING REPEATED ON A DAILY BASIS ALL OVER THE WORLD. AT THIS POINT IT BECAME APPARENT WE WERE AT AN IMPASSE. IT WAS TIME TO GET TO THE OFFICE, SO I THANKED HIM FOR THE INVITATION. AS WE STARTED TO WALK AWAY, HE SAID "DON'T FORGET WE (GOA) HAVE AGREED TIMERMAN SHALL NOT BE FREED."

7. FUTURE MEETINGS WITH CAMPS: AS HE SAW US OFF, CAMPS TOLD ME HE WANTED ME TO RETURN TO HISHDOTRS. ON AUGUST 8 AS HE WAS HAVING A HORSE EXPOSITION ON THAT EVENING. HE ALSO STATED HE WANTED ME TO TRAVEL WITH HIM TO ENTRE RIOS TO SPEND THE DAY VISITING HIS HORSE FARM. HE THEN SMILED AND SAID "WE WON'T DISCUSS POLITICS." I REPLIED THAT IN DRDER TO BETTER UNDERSTAND PROBLEMS BETTER A DIALOGUE ABOUT THEM WAS ESSENTIAL.

8. COMMENT: GENERAL CAMPS MADE IT CLEAR HE WAS ONE OF GENERAL SUAREZ MASON'S GOOD FRIENDS AND SUPPORTERS. HE ALSO DESCRIBED SOME OF HIS EXPERIENCES WHEN HE WAS IN CHARGE OF THE POLICE IN BUENOS AIRES PROVINCE. WITH GREAT BRAVADO, HE TOLD ME HE WAS THE INVESTIGATOR OF THE TIMERMAN AND GRAVIER CASES. HE IMPLIED HE WAS THE TIMERMAN EXPERT. IN ALL MY SEVEN AND ONE HALF YEARS OF DEALING WITH "RIFFF-RAFF" AND CRIMINAL ELEMENT AS A DISTRICT ATTORNEY, I HAVE NEVER SEEN ANYONE AS POTENTIALLY DANGEROUS AS THIS PERSON. I LEFT HIM WITH A FEELING HE WAS MENTALLY SICK. I ALSO LEFT WITH THE FEELING HE IS THE BIGGEST OBSTACLE TO TIMERMAN'S RELEASE. I HAVE HAD MANY SESSIONS WITH GENERAL SUAREZ MASON AND SHALL HAVE A FE MORE, BUT NEVER HAD I ENCOUNTERED AN EXPERIENCE AS THIS ONE. I SHALL CONTINUE TO TALK WITH SUAREZ MASON AND CAMPS AT EVERY OPPORTUNITY WITH THE HOPE I MIGHT WEAR THEM DOWN BEFORE THEY UNDO ME.
