SEVEN OTHERS WERE FOUND APPROXIMATELY 20 KILOMETERS NORTH OF TINGO MARIA. AS NO OUTSIDE OBSERVERS ARE BEING GIVEN PERMISSION TO ENTER THE AREA, THE NUMBERS OF THOSE FOUND KILLED COULD GO HIGHER IF OUTSIDE ACCESS WERE TO BE GRANTED. THERE HAS ALSO BEEN ONE UNCONFIRMED OPEN PRESS REPORT THAT SAID THIS OPERATION MAY BEGIN AGAIN IN THE NEAR FUTURE (b)(1),Sec. 1.4(c)

C. (S/NF/WN) SO FAR, THE PERUVIAN GOVERNMENT'S RESPONSE HAS FOLLOWED THE PATTERN DEVELOPED DURING THE LA CANTUTA HUMAN RIGHTS CASE OF 1993 AND EARLY 1994. WHILE ADMITTING TO CONDUCTING AN OPERATION IN THE AREA, THE GOVERNMENT DENIES ANY RESPONSIBILITY FOR THE REPORTED ATROCITIES. IF CIVILIANS WERE MURDERED, ACCORDING TO THE MILITARY, THEY MUST HAVE BEEN THE VICTIMS OF SENDERO LUMINOSO. THEY HAVE ALSO THROWN UP BARRIERS TO OUTSIDE SCRUTINY SUCH AS NOT ALLOWING IN OUTSIDE OBSERVERS. ALSO, IN A THROWBACK TO THE LA CANTUTA PERIOD, BOTH THE ARMY AND PRESIDENT FUJIMORI HAVE VEHEMENTLY DENOUNCED THOSE ACCUSING THE MILITARY OF WRONGDOING. THIS HAS INCLUDED SOME VERY HEATED VERBAL ATTACKS AGAINST THE INTERNATIONAL RED CROSS AND PERUVIAN PRESS. ON 28 APRIL, THE RULING MAJORITY IN CONGRESS PASSED A RESOLUTION CONDEMNING THE HUMAN RIGHTS UMBRELLA GROUP COORDINADORA FOR "IRRESPONSIBLY" PROPAGATING ALLEGATIONS OF HUMAN RIGHTS ABUSES BY THE MILITARY. THIS TYPE OF CONDEMNATION IS UNPRECEDENTED. FINALLY, NO SERIOUS, AGGRES-SIVE INVESTIGATION HAS BEEN INITIATED BY THE GOVERNMENT AND NONE IS EXPECTED SOON. THE TWO GOVERNMENT BODIES WHICH MAY BE TASKED TO INVESTIGATE HUMAN RIGHTS ABUSES, THE ATTORNEY GENERAL'S OFFICE AND THE CONGRESSIONAL HUMAN RIGHTS COMMITTEE, ARE BOTH CONTROLLED BY MEMBERS OF PRESIDENT FUJIMORI'S POLITICAL PARTY. OF NOTE, THE ATTORNEY GENERAL AND THE CHAIRMAN OF THE PERUVIAN CONGRESS HUMAN RIGHTS COMMIT- TEE HAVE BOTH RECENTLY VISITED TINGO MARIA ON "FACT FINDING" MISSIONS, ATTORNEY GENERAL BLANCA NELIDA COLAN ANNOUNCED ON 27 APRIL THAT SHE WAS DESIGNATING THE TINGO MARIA DISTRICT ATTORNEY AS A SPECIAL PROSE-CUTOR TO INVESTIGATE ALLEGATIONS AGAINST THE ARMY.

HAVE IMPROVED SUBSTANTIALLY OVER THE PAST TWO YEARS WITH SOME EXCEP-TIONS. MOST IMPORTANTLY, DISAPPEARANCES AND EXTRAJUDICIAL KILLINGS ATTRIBUTED TO SECURITY FORCES HAVE BEEN DRAMATICALLY REDUCED. ACCORD- ING TO HUMAN RIGHTS GROUPS OVER 350 SUCH DISAPPEARANCES OCCURRED IN 1991. THIS WAS REDUCED TO JUST OVER 64 IN 1993. IN THE 1980S AND EARLY 90S WIDESPREAD SUMMARY EXECUTIONS OCCURRED. AND SECURITY FORCES HAD A COMMON PRACTICE OF ENTERING VILLAGES IN SEARCH AND DESTROY OPERATIONS SIMILAR TO THOSE HAVING BEEN ALLEGED THIS APRIL. DEATH SQUADS ALSO OPERATED WITH IMPUNITY IN THE COUNTRYSIDE AS WELL AS IN THE CAPITAL OF LIMA. BEGINNING IN 1991, HOWEVER, A TREND DEVELOPED TOWARD FEWER NUMBERS OF SUCH KILLINGS, AND SEARCH AND DESTROY METHODS WERE EVENTUALLY DISCARDED. IN ADDITION TO THESE CHANGES IN COUNTERIN- SURGENCY POLICY, A NUMBER OF OTHER PROGRAMS HAVE BEEN INTRODUCED. OVER THE PAST YEAR, FOR EXAMPLE, THE PERUVIAN ARMY HAS BEGUN ASSIGNING LIEUTENANTS AT BATTALION LEVEL AS HUMAN RIGHTS OFFICERS. THIS IS NOW ONGOING IN FIELD UNITS THROUGHOUT THE COUNTRY. THE RED CROSS AND OTHER ORGANIZATIONS HAVE ALSO GIVEN THE ARMY AND POLICE NUMEROUS CLASSES ON INTERNATIONAL HUMANITARIAN LAW. PREVIOUS RELUCTANCE OF THE GOVERN-MENT TO GRANT OUTSIDE MONITORING OF THE HUMAN RIGHTS CONDITIONS IN PRISONS AND MILITARY BASES APPEARS TO BE IMPROVING AND NUMEROUS VISITS TO PRISONS, JAILS, POLICE STATIONS, AND MILITARY FACILITIES BY HUMAN RIGHTS ACTIVISTS HAVE BEEN ALLOWED. FINALLY, PERU HAS ESTABLISHED A NATIONAL REGISTRY OF DETAINEES WHICH WILL ALLOW SOME ACCOUNTABILITY OF PEOPLE INCARCERATED.

TYPES OF ABUSES AND DISAP- PEARANCES APPEAR TO BE OCCURRING MOST OFTEN IN THE HUALLAGA AND PUCALLPA FRONTS, THE FRONT LINES IN THE INSURGENCY WAR. POSSIBLY THE BIGGEST PROBLEM, THOUGH, CONCERNS THE LACK OF ACCOUNTABILITY FOR PAST MILITARY HUMAN RIGHTS ABUSES. ONLY EIGHT HUMAN RIGHTS CASES COMMITTED BY PERUVIAN MILITARY MEMBERS HAVE BEEN RESOLVED IN THE LAST EIGHT YEARS AND FOUR OF THOSE WERE DISMISSED DUE TO LACK OF EVIDENCE.
