- 1. (C) ON NOVEMBER 5, THE AMBASSADOR MET WITH MINISTER OF DEFENSE GILBERTO ECHEVERRI AND, ON NOVEMBER 7, WITH ARMED FORCES COMMANDER MAJOR GENERAL MANUEL JOSE BONETT. IN THESE MEETINGS, THE AMBASSADOR RAISED THREE OUTSTANDING HUMAN RIGHTS ISSUES: THE KIDNAPPED NEW TRIBES MISSIONARIES, THE OCTOBER PARAMILITARY MASSACRE IN MIRAFLORES, AND THE SUSPECTED TIES OF A HIGH-LEVEL ARMY OFFICER TO NARCOTRAFFICKERS AND PARAMILITARIES.
- 2. (C) NEW TRIBES MISSIONARIES. IN HIS MEETING WITH MINISTER ECHEVERRI, THE AMBASSADOR PRESSED THE MINISTER FOR MORE INFORMATION ABOUT THE THREE NEW TRIBES MISSIONARIES KIDNAPPED BY THE FARC IN JANUARY 1993. MINISTER ECHEVERRI HAD PROMISED THE AMBASSADOR THAT HE WOULD MAKE FURTHER INQUIRIES REGARDING THE MISSING MEN, AND THE AMBASSADOR TOOK THIS OPPORTUNITY TO FOLLOW UP ON THAT PROMISE. ON NOVEMBER 6, ECHEVERRI SENT THE AMBASSADOR A LETTER DATED OCTOBER 16 FROM ARMED FORCES COMMANDER MAJOR GENERAL BONETT, ASSERTING THAT A PRIEST FAMILIAR WITH THE AREA FROM WHICH THE MISSIONARIES DISAPPEARED INFORMED THE GOC THAT THE MEN HAD BEEN ALIVE AS RECENTLY AS THE SUMMER OF 1996.

THE AMBASSADOR SAID THAT COLOMBIAN NATIONAL POLICE DIRECTOR ROSSO JOSE SERRANO PROMISED A FULL REPORT OF THE DANTI'S ROLE, BUT THE AMBASSADOR WANTED TO BE SURE THAT ECHEVERRI WOULD LOOK INTO THE MILITARY'S PARTICIPATION IN THE INCIDENT. ECHEVERRI TOLD THE AMBASSADOR THAT ONDCP DIRECTOR MCCAFFREY MENTIONED MIRAFLORES DURING THE MINISTER'S RECENT TRIP TO WASHINGTON, THAT AN INVESTIGATION OF THE ARMY'S ROLE IN THE INCIDENT WAS UNDERWAY, AND THAT BOTH THE ARMY AND POLICE REPORT WOULD BE MADE AVAILABLE TO THE EMBASSY AS SOON AS THEY WERE READY.

(C) IN HIS MEETING WITH GENERAL BONETT ON NOVEMBER 7, THE AMBASSADOR REITERATED THE POINTS HE MADE TO MINISTER ECHEVERRI, AND URGED THE GENERAL TO MOVE QUICKLY ON AN INVESTIGATION SO THAT THE GOC'S SIDE OF THE STORY COULD BE TOLD. THE GENERAL ECHOED MINISTER ECHEVERRI'S PROMISE TO FULLY LOOK INTO THE MATTER.
- 5. (C) GENERAL'S TIES TO NARCOS AND PARAMILITARIES. SEVERAL MONTHS AGO, THE AMBASSADOR SPOKE WITH JUAN CARLOS ESGUERRA, ECHEVERRI'S PREDECESSOR, ABOUT MAJOR GENERAL IVAN RAMIREZ
