Kerri:

I don't have a formal read-out. Basically, the NGOs expressed continuing concern about the project and follow on hydrocarbon development. They also expressed frustration in their interactions with IDB on Camisea, and were hoping to enlist USG support for their proposals for an independent audit of the project and an independent monitor. A/S Quarles reminded them that the US vote on the project had upset the GoP and reduced our leverage relative to if we had voted for it. Still, he thought that the current finance minister might be more open to discussing such proposals than the minister's predecessors. I offered to meet with NGOs if they wanted to flesh out these proposals. The NGOs also discussed the IDB's proposed environment policy with A/S Quarles who assured them that Treasury was following it closely.

I have proposed just a few edits to the cable. I have also attached two documents recently transmitted to IDB as follow ups to meetings with them. In "Camisea closure actions 1, Annex B is most relevant to bilateral communication with the GoP as it lists actions that we had deemed incomplete under the LoC.

Also, note the suggestion that USG send observers to the next meeting among IDB, sponsors, GoP, and Peruvian civil society organizations. A/S Quarles met with a US NGOs yesterday and left the door open for possible USG support for an independent audit and/or independent monitor but we would need to get further information on what is being proposed for these mechanisms first. So getting a read-out from the next Lima meeting would be helpful.
